Dedicated to improving the healthcare needs of the southwest Iowa community.

- ❖ CFOC is led by Methodist Jennie Edmundson Hospital and is available throughout southwest Iowa at no cost.
- ❖ In 2023, CFOC assisted 3,472 individuals, and distributed \$151,868 in financial assistance.
